If your association is considering tackling certification, licensure, or registration in your association's state, this is the conference for you! Even if this is an effort that will not be attempted in the near future but that you know your state will eventually investigate, it is important to learn the different types of regulation; the status of regulation efforts in other states; how to handle legal professions who are not keen on regulation; and, understanding the legislative process. This conference is an important one to attend in order to gain an understanding of what your state is likely to come up against in its future endeavor into regulation.

## Paralegal CORE Competency Exam by Suellen Honeychuck, RP

A pilot test of the Paralegal CORE Competency Exam took place on June 11, 2011 at various locations throughout the country. Out of the 224 candidates registered to take the exam, 188 took the exam and 146 candidates achieved a passing score of 550 or better. The exam is now available to all eligible paralegals. Registration is made on NFPA's website. The fee to take the exam is \$215.00.

The computer based exam is 125 multiple choice questions, taken in a two hour period. The exam is given at a Prometric Testing Center. Eligibility requirements to sit for the exam consist of a combination of education and work experience criteria. For those who have extensive work experience, some CLE components must be met to be eligible to take PCC exam.

Scoring Runs for the PCC Exam will be completed quarterly according the following schedule:

#### **RENEWALS** by Vickie Newman, RP

Now is the time to submit renewal applications for those whose exam dates were in **January, February, March and April**. As a reminder, you do not need to submit any of the seminar materials. This includes handouts, PowerPoint presentations and the like. You do need to submit copies of the certificates of attendance. If the seminar was approved by NFPA's CLE Coordinator, you also need to submit the letter of approval. This will avoid any unnecessary delays in processing the renewal application.

In submitting CLE hours, the look-back period is six months. You can use up to three (3) hours of CLE if they were obtained within the past six months and not used in your prior renewal period. Ethics *cannot* be carried over.

Up to four (4) hours of CLE may be obtained for self-study. If the program is not a NFPA pre-approved provider (i.e., NFPA, NFPA member paralegal associations, state and local bar associations, government agencies, courts, IPE, and NALA to name a select few), you must obtain approval from NFPA's CLE Coordinator first.
