

I want to thank everyone who attended the Certification Ambassadors' Conference in Nashville in April. We had a good turn out and it was a great time to meet and network with Certification Ambassadors from around the country.

I know that everyone is asking when the PCCE™ Study Manual will be ready. Everyone involved is working very hard to get it completed and I believe it will be available mid- to late June. I know it's been a long wait, but I promise it will have been worth it. Candidates will be able to purchase the study manual directly through NFPA's website; Order fulfillment will be handled by OmniPress. Keep in mind the PACE® Study Manual continues to be available from Pearson Publishing also through the NFPA website. Also, please note that the PACE® Application and Candidate Handbook which was previously available from Pearson Publishing will now be purchased directly from NFPA. Once the \$25 cost for the handbook has been processed, NFPA staff will send you an email with a downloadable PDF of the handbook.

I also want to let you know that API, the same vendor that provides the PACE® online review course, now has an online review course ready for the PCCE™. Information has been posted to NFPA's Facebook page, NFPA's LinkedIn page and an email blast was sent to all members concerning this new review course. The first scheduled course begins on June 4, 2012. You can also find details on the NFPA website and can register for the course through the NFPA website.

I've had several RPs suggest that the post card renewal reminders seem to get lost in the mail, especially if they work for a large firm or corporation. Therefore, we are going to establish procedures to send renewal reminders by email. So, please remind your RPs and also CRPs that they should make sure to have a current, valid email on file with NFPA headquarters.

PCCE™ Review Course Now Available!

The National Federation of Paralegal Associations (NFPA[®]) and the Advanced Paralegal Institute (API) are jointly offering the online review course for the Paralegal Core Competency Exam (PCC). The PCC Exam is targeted to paralegals who have recently graduated from a paralegal education or training program or are within their first two years of practice. The exam was launched in November of 2011 and focuses on those essential aspects of practice in which an entry level paralegal would be expected to be competent. Exam questions are based on information from course work in various paralegal programs and basic knowledge all paralegals should possess. The on line review course runs for seven weeks, plus a brief pre-course orientation to familiarize students with the web site and First Class used by API. API courses are taught through computer-mediated distance learning. Students may communicate with instructors or classmates around the clock from their home or office computer.

The review course will help paralegals prepare to take the PCC exam by covering the two domains tested: Paralegal Practice and Substantive areas of law. Each unit will begin with a pre-test, which will allow students to assess their strengths and weaknesses in the area being studied. Readings will be assigned and discussion questions included in each unit, which will focus on problem areas

revealed in the pre-test results as well as the new material introduced in the unit. At the end of each unit a post-test will be given, which will allow students to assess where additional independent study may be helpful. The text for this course is *Introduction to Law for Paralegals*, 5th Ed., by Currier and Eimermann (Aspen, 2012). An exit PCC exam will be administered at the conclusion of the course. Each student will receive a score and an analysis of the student's strengths and weaknesses.

 - Additional courses may be added if sufficient interest is expressed.
- Tuition for the PCC Review Course is \$395. Please note there is no refund once the course begins. If you wish to withdraw or drop the class after it begins, you may take it again within one year at 1/2 the current tuition cost.
- Students who take the PCC Review Course are not guaranteed to pass the PCC exam or necessarily be eligible to take the PCC exam. Students who have taken the PCC Review Course and fail the PCC exam may retake the Review Course for a second time, within a one year period, for 1/2 price of current tuition rate.
- Registration for this Review Course does not automatically register you to take the PCC exam. You must submit a separate application to take the PCC exam.

Paralegal CORE Competency Exam (PCCE™) Assurance of Learning Affiliate Program

NFPA has recently announced the **Paralegal CORE Competency Exam (PCCE™) Assurance of Learning Affiliate Program** that offers paralegal educational institutions a nationally validated and highly cost effective means of assessing, tracking and reporting on the outcomes of their graduates relative to the critical learning domains of paralegal education that are tested by the PCCE™. Each school that participates in the PCCE™ Assurance of Learning Affiliate Program will receive an annual **School Performance Report** from NFPA, including detailed school-specific outcomes data.

The PCCE™ Assurance of Learning Affiliate Program delivers the following benefits to participating schools:

1. A means of tracking and reporting on outcomes of graduates, relative to the key domains of knowledge.
2. A means of demonstrating that graduates have acquired the knowledge required for entry-level paralegal practice.
3. A means of evaluating the effectiveness of a school's paralegal education curriculum.
4. A means for graduates who pass the PCCE™ to differentiate themselves in the marketplace.

RENEWALS

Please do not submit any seminar materials, handouts, PowerPoint presentations and the like with your PACE Renewal Application. Doing so delays approving your renewal. We do not need to see the actual seminar material. This applies *only to PACE Renewal Applications* and not to requests for CLE approval.

If you are not sure if your CLE is pre-approved, take a look at the brochure advertising the seminar. The seminar host will include information as to who is granting the CLE, such as a state bar association, NFPA, or NALA. In granting CLE hours, the brochure will say "approved by NFPA for 3 hours general credit" or "approved by State Bar of California for 2 hours in ethics". This information is generally found on the front of the brochure so that potential attendees know who is granting the CLE credits.

Please remember that you can carryover three (3) hours of CLE from the previous reporting period if the seminar(s) was taken within the last six months of your previous reporting period. For example, if your renewal is in December 2012, you can carryover three hours of CLE for seminars taken between July and December 2012, provided that you did not use them. You will need to re-submit your prior PACE Renewal Application, along with your current one, to show that you did not claim them in the prior renewal period. Ethics *cannot* be carried over but must be taken in the current renewal period.

Now is the time for paralegals who took PACE between July and December in an even numbered year to submit their PACE Renewal Applications.
