  - e. Does your employer reimburse you for expenses to take PACE?
  - f. Does your local paralegal association offer PACE scholarships? If so, please describe the eligibility requirements, frequency, and amount of the scholarship.
  - g. Are there any other factors that you would like the Judges to consider regarding your application for the PACE Scholarship? If so, please list:
4. Write an essay (no more than 4 pages) responding to the question: **“Discuss whether paralegal credentialing exams such as PACE® have a role in paralegal regulation, and if so, how?”** Your essay is not intended to be a research paper, nor is it intended to simply repeat wording from the PACE pages of the NFPA website. Originality is encouraged. Grammar and punctuation will also be considered in the overall score given to your essay.
